Images Consent (Parents and Carers)

As you are aware, there are many occasions in school when we wish to take photographs or make video recordings of pupils at Stowford School. Occasionally the local press come into school to take photographs of our children "in action", for example new intake supplements or Christmas productions; we also supply local papers and magazines with news items for inclusion in their publications. We also include photographs of the school at work on the school website www.stowford.devon.sch.uk and the Trust website www.westst.org.uk. as well as in publications shared with Trust schools. The images are accompanied by first names (and first initial of surname) only.

In order to comply with the General Data Protection Regulation, the school needs your consent before taking photographs or making video recordings of your child for purposes which are not core activities. We would therefore be grateful if you could answer the questions overleaf, sign each section, date the form and return it to school as soon as possible.

Conditions of Consent

- 1. An 'Images Consent Database' is kept in school showing Parents' and Carers' preferences with regard to use of their child's image and name (as expressed on the Images Consent Form). Where a consent form is not held for a child, the school will not use their image.
- 2. The database will be consulted before images or names are used for any publicity purpose.
- 3. If consent has been given for all purposes, no further consent will be sought.
- 4. If consent has not been given, the parent or carer may be approached for permission to use their child's image either one time only, or in group photos, or in all future photos. The database will be updated accordingly.
- 5. Where possible, publishing close up or individual photographs of children will be avoided. The school's preference is to publish class, team or group images of pupils. The aim is to strike a balance between protecting pupils' identities and giving them due credit for their achievements.
- 6. Photographs published on the school/Trust website, or elsewhere that include pupils will be selected carefully and will comply with good practice guidance on the use of such images.
- 7. Names of pupils may be used in Press Releases and on the school and Trust websites as specified in the Images Consent Database.
- 8. The form will be valid indefinitely from the date of signature. At any time, a Parent or Carer has the right to withdraw any or all consent previously given. This removal of consent will be actioned by the school without reasonable delay upon the submission of a signed 'Withdrawal from Consent' form, available on the school's website.
